## NOTIFICATION

In order to reduce compliance burden and deregulation for Ease of Doing Business and also to ensure timely disposal of Consent Applications for issue of Consent to Establish Certificate and Consent to Operate Certificate, the Tripura State Pollution Control Board hereby issues the following orders for effective implementation in the State:

### **(i) Self-Certification for Consent to Establish and Consent to Operate Certificate :**

Self-Certification is hereby introduced for issuance of Consent to Establish Certificate and Consent to Operate Certificate for all categories of industrial sectors/ sub-sectors, which are having capital investment upto Rs.50 lakhs. To obtain Consent to Establish and Consent to Operate Certificate from the Board, the project proponents shall have to submit online Application Form and Self-Certification (*in the prescribed format provided as Annexure-A*). The project proponents shall have to pay Consent Fees as applicable along with other necessary documents as required for issue of Consent to Establish and Consent to Operate Certificate.

### **(ii) Third Party Inspection/ Certification for Consent to Establish/ Consent to Operate Certificate :**

The Third-Party Inspection/ Certification is hereby introduced for all Categories of Industries having capital investment more than Rs.50 lakhs for issue of both Consent to Establish Certificate as well as Consent to Operate Certificate. The procedures/guidelines for empaneling the list of agencies/ environmental auditors for Third Party Inspection/ Certification is enclosed as **Annexure-B**.

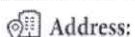
### **(iii) Auto Renewal of Consent to Establish & Consent to Operate Certificate :**

#### **(a) For issue of Consent to Establish Certificate :**

Auto Renewal of Consent to Establish Certificate for further 3 (three) years validity period is hereby introduced irrespective of any Capital Investment of the project. Auto Renewal of Consent to Establish Certificate shall be made subject to online submission of Requisition Letter (*prescribed format enclosed as Annexure-C*) and last Consent to Establish Certificate by the project proponent. The project proponent will not be required to pay any Consent Fees for this purpose.

#### **(b) For issue of Consent to Operate Certificate :**

Auto Renewal of Consent to Operate Certificate (CTO) is hereby introduced for all categories of industrial sectors/ sub-sectors irrespective of any Capital Investment of the



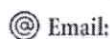

project. The industries, having capital investment upto Rs.50 lakh, shall submit an online Application Form and Self-Certification (**Annexure-A**) for Auto Renewal of Consent to Operate Certificate. The industries, having capital investment more than Rs.50 lakh, shall submit an online Application Form and Third-Party Inspection Report/ Certification from the empaneled Agencies for Auto Renewal of Consent to Operate Certificate.

These apart, the project proponents shall have to pay Consent Fees as applicable along with other necessary documents as required for auto renewal of Consent to Operate Certificate.

**NB:-** In the case of Closure Order/ Court Case Pending before National Green Tribunal / any Judicial Authority/ Appellate Authority, the aforesaid provisions of Auto-Renewal of Consent to Establish/ Consent to Operate Certificate will not be applicable till disposal of the court case/ satisfactory compliance.

This is issued in supersession to earlier Notification No.F.17(30)/TSPCB/EODB/Vol-III/13631-45 dated 22/10/2020. This Notification is effective from the date of issue and shall remain in force until further orders.

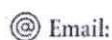

## Annexure-B

### **The Procedures/Guidelines for empaneling the list of agencies/ institution/environmental auditors for Third Party Inspection/ Certification**

The Third-Party Inspection/Certification is hereby introduced for all Categories of Industries having capital investment more than Rs.50 lakh for both Consent to Establish Certificate as well as Consent to Operate Certificate. The procedures/guidelines for empaneling the list of agencies/institution/environmental auditors for Third Party Inspection/ Certification are as follows: -

- (i) TSPCB will invite expression of interest for empaneling the list of agencies/institution/environmental auditors for Third Party Inspection/ Certification.
- (ii) TSPCB will constitute a Technical Expert Committee for framing the eligibility criteria of the agencies/institution/environmental auditors and also to evaluate the Expression of Interest for empanelment of the agencies/institution/environmental auditors for Third Party Inspection/ Certification.
- (iii) The Tripura State Pollution Control Board will empanel the list of agencies/institution/environmental auditors for Third Party Inspection/ Certification.
- (iv) The empaneled agencies/institution/environmental auditors will be entrusted to inspect the projects / industries to check the compliances of terms and conditions of Consent to Establish Certificate and Consent to Operate Certificate, Environment Clearance (if applicable) & air monitoring/ stack monitoring, other environmental parameters as notified from time to time.
- (v) The choice of agencies/institution/environmental auditors for a specific industry shall be made by the TSPCB on a random selection basis from the panel of agencies/institution/environmental auditors.
- (vi) The empaneled agencies/institution/environmental auditors shall not inspect the industries, if there is a public complaint, legal case, or which in the opinion of the Board do not deserve such exemption. In these cases, normal inspections will be made by the Board.
- (vii) The Project Proponent/ Industry shall have to bear the expenses incurred towards inspection and monitoring by the empaneled agencies/institution/environmental auditors for third party inspection/certification.
